Call to Order at 1:04 by Ruth Ann Copley, President

- Treasurer's Report Margaret Marshall reported.

The beginning balance as of 4/1/2013: \$42,739.89

During this period we have taken in \$8,850 in Friends of the Library donations. Margaret reminded everyone that it was not too late for Friends donations.

The ending balance as of 7/31/2013: \$46,470.87

Margaret also reminded everyone that if they were not dues paying members of NCPLDA their libraries would not be eligible for Ancestry and African American Heritage database discounts.

AWE –Brian Aertker presented information about AWE computer systems for children.

Innovative Library Programming and Library Hip Hop – Scooter Hayes of New Hanover County Public Library entertained everyone with his story of how he got started working in the public library and the

early literacy programming that he does at the New Hanover County Public Library. (see storyyeller.com). His early literacy programming at New Hanover County Public Library includes music, storytelling festivals, story walks, and other innovative early literacy programs.

Legislative Committee. Co-chairs Ross Holt and Jody Risacher presented information about the new legislative efforts webpage and future legislative plans.

David Miller created the site (https://sites.google.com/site/ncpldalegislative/Advocacy) in Google sites. The site is linked off the NCPLDA website. The site is divided into subsections. Subcommittees were formed to fill out the content.

Introduction to North Carolina State Government. This section was presented by Louise Humphrey and Mary Sizemore. The section includes information related to General Statutes and Libraries, State Aid to Public Libraries, State Budget process, and useful links regarding the General Assembly.

Carol Wilson requested more information about Federal legislation to the site. Wanda Brown suggested that NCLA work together with NCPLDA on legislative efforts both at the state and federal levels.
