NC LIVE - Tim Rogers, Executive Director. Tim presented information about the NC LIVE including:

- New York Times available through 12/31/2013
- Statistical Abstract of the US available through 3/31/14
- OCLC First Search Base Package being evaluated now under contract through 12/31/2013
- Library contact review underway
- Learning Express new interface this fall (accounts will not transfer)
- NC Knows chat boxes in EBSCO and ProQuest
- Implementation of EDS
- Biennial meeting (opposite of NCLA) starting fall 2014
- Changes
 - Philosophy
 - There is no anticipated change in philosophy.
 - NC LIVE will be exploring "right sizing" some of the licensing deals.
 - They hope they can put the structure in place for libraries to grow organic digital collections.
 - Usage Patterns of Resources
 - Usage is going down, but mainly due to changes in content and the way that usage data was collected for some of the databases
 - Funding
 - Last funding increase from public libraries was in 2004. Overall NC LIVE has lost \$500,000 since 2006
 - Seeds of Solutions

- NC LIVE Foundation was established on 1/15/2013. It will be a separate 501(c)(3).
- They can now develop funding raising plan without relying on tax money
- Content Strategy things public libraries need to think about for the future:
 - What eContent is important to PLs?
 - How do you want it to be used?
 - How do you want to acquire it?
 - How can you pay for it?
 - How can/does NC LIVE fit in your strategy?
- Next things.
 - Three year licensing cycle planning begins soon.
 - Value/willingness to pay model
 - o RAC Summit in spring 2014
 - Decisions by July 2014
